# Mikayla's BSWC Term Wrap-Up

After joining the Big Sky Watershed Corps program in January, I was fortunate enough to have been placed with the Friends of the Missouri Breaks Monument for my 10-month term of service. Since then, the work, the landscape, and the people that have made up my time with the Upper Missouri River Breaks National Monument have bolstered my passion for both the breaks and for the incredible work that this organization does in service of our public lands and the people they benefit.

Much of my work this year has been spent on the water. Between maintenance floats, Wilderness Study Area trips, and river clean-ups, I paddled almost 320 miles on the Missouri river between Wood Bottom campground and James Kipp Recreation Area learning about the history, ecology, and geology of the breaks along the way. These trips included campground maintenance, vegetation monitoring, cottonwood watering, and educating visitors about the monument and the work the Friends does to protect it. Each float on the Missouri offered a new and exciting experience; whether it was battling 14 miles of headwinds alone in a canoe or sleeping under the stars at Hole in the Wall listening to a chorus of coyotes, I never left the water without a story to tell.

However, the most rewarding part of my time with the Friends has been during our many volunteer events. I feel extremely privileged to have met and worked alongside so many supporters of the Friends during these stewardship days while also getting the chance to enhance my own professional development. Organizing projects like the National Trails Day maintenance hike, Interpretive Center Beautification Day, Missouri River Clean-up Float, and National Public Lands Day at James Kipp afforded me the opportunity to see plans become reality and to witness the dramatic benefits that a small group of people can provide with a lot of hard work.

I want to thank all of you for your warm welcome and tireless efforts to leave this world a better place than you found it. Although each one of you has his or her own unique connection to the monument, this has proven to be a community of people that can and will readily come together to do an immense amount of good. I am grateful for every moment that I have spent as a part of this organization and I look forward to seeing you all on the monument in the future. As one volunteer so aptly phrased it, "paddle on"!

#### **Breaks Action Team**

While stewardship is often seen as the outward face of the Friends, there is more going on than what is seen on the ground. This year, the Friends reached out to other Montana-based conservation groups to build a collation of advocates for the monument and its surrounding landscapes. The coalition, called the Breaks Action Team (BAT), includes the Friends, Montana Wildlife Federation (MWF), and Montana Wilderness Association (MWA). Like the Friends, MWF and MWA have been fighting to protect Montana's natural resources for years, long before the monument's creation even. Individuals focused on central and eastern Montana from both organizations join staff from the Friends on monthly calls, at a minimum, to discuss issues in the region. This cohesion and communication will allow all organizations the ability to track monument related matters and build a joint game-plan as problems arise.



### **Looking Ahead to 2021**

On January 17<sup>th</sup>, 2021, the Upper Missouri River Breaks National Monument will turn 20! Just months after on April 18<sup>th</sup> the Friends will join its namesake and focus as the organization turns 20. Both of these anniversaries are cause to celebrate and celebrate we will!

In 2021, the Friends will be ramping up operations and are committed to functioning within all three of our mission statement's directives; advocacy, education, and stewardship. In accordance with this move, the Friends will be continuing all of our stewardship work, adding educational events about subjects related to the monument, and hosting talks with conservation advocates. As the current health crisis plays out, we will be making decisions about in-person events or virtual gatherings for many of these programs in the coming months. Please keep an eye out for a complete schedule this winter and early spring.
